NOTE: "Year" means financial year i.e from 1 Jan to 31 December.

(A) "NEW SHAREHOLDER" SCHEME FOR NTUC UNION MEMBERS / NTUC GENERAL BRANCH (GB) MEMBERS

1. Please complete this form and submit to NTUC FairPrice with payment by cheque for \$23 (20 shares at S\$1 each plus \$3 entrance fee). Cheque should be made payable to "NTUC Fairprice Co-operative Ltd". This form must be endorsed by your union. Incomplete / inaccurate application will be rejected.
2. No FairPrice card will be issued to NTUC union members and NTUC General Branch members as their NTUC Plus card can be used at FairPrice supermarkets.
3. Members must be at the age of 16 years and above.

(B) "JOIN-NOW-PAY-LATER" SCHEME FOR NTUC UNION MEMBERS / NTUC GENERAL BRANCH (GB) MEMBERS

1. Only open to NTUC Union members and NTUC General Branch members who have attained the age of 16.
2. Please Complete this form and submit to NTUC FairPrice without payment. This form must be endorsed by your union. Incomplete / inaccurate application will be rejected.
3. You must have the NTUC Plus card for use at FairPrice Supermarkets. No FairPrice card will be issued.
4. Within 3 years from the year of your first purchase at any FairPrice supermarket, you must accumulate \$23 rebate to pay off your 20 shares (at \$1 each) plus \$3 entrance fee. Any excess rebate will be refunded to you. If after 3 years your rebates are less than \$23 you will have to top up the difference to become a FairPrice member, otherwise, past years rebates will be forfeited.

(C) IMPORTANT NOTES

1. Members may apply for 20 shares only (at S\$1 each) plus \$3 entrance fee.
2. The Board of Directors reserves full discretion to approve or reject any application for new shares.
3. There is a cap on patronage rebate which will be subjected to review at the discretion of the Board of Directors. The rate of rebate will be declared at the Annual General Meeting each year.
4. Membership will cease upon cessation of union membership or any other qualifying criteria in accordance with the By-laws.

(A) 职总工会会员/职总一般性会员的“新股份会员”计划

1. 请将填妥的表格, 连同\$23的支票(20股 - 每股\$1及\$3入会费)呈交给职总平价。支票必须注明祈文“NTUC FAIRPRICE CO-OPERATIVE LIMITED”。此表格必须由各自所属的工会盖上图章, 若表格不完整或有错误将一律不被接受。
2. 职总工会会员及职总一般性的会员都可在平价超级市场使用NTUC Plus Card. 因此职总平价将不额外分发平价会员卡。
3. 会员必须满16岁或以上。

(B) 职总工会会员/职总一般性会员的“先参加后付款”的计划

1. 只限满16岁或以上的职总工会会员及职总一般性的会员。
2. 请将填妥的表格呈交职总平价, 无须付款。填妥的表格必须由各自所属的工会盖上图章, 若表格不完整或有错误将一律不被接受。
3. 职总平价将不额外分发平价会员卡。你必须持有一张NTUC Plus Card, 以方便你在平价时使用。
4. 从你第一次在平价超级市场使用会员卡消费, 你必须在三年内累积至少\$23的回扣来支付20股(每股\$1)和\$3入会费。经扣除所剩的数额将退还给你, 如果你在三年内所累积的回扣少过\$23, 你必须以现金支付差额, 否则所有的回扣将被抵消。

(C) 重点

1. 会员只可申请20股 (每股\$1)另加\$3入会费。
2. 董事会将有权利批准或拒绝任何新股的申请。
3. 购物数额所得的回扣将设有顶限, 数额将由董事会审核及决定。回扣率将在每年的常年会议上宣布。
4. 根据章程, 会员一旦停止参加任何工会或团体, 平价会员的资格将会自动失效。
